

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN of a Public Hearing to be held by the Bucks County Industrial Development Authority (“Authority”) with respect to a project involving the issuance of tax-exempt obligations constituting a qualified small issue bond under Section 144(a) of the Internal Revenue Code of 1986, as amended, to finance the Project described below. The Hearing will be held on October 25, 2022 at 9:00 a.m., prevailing Eastern time, at the offices of the Authority’s Counsel, Begley Carlin & Mandio, LLP, 680 Middletown Boulevard, Langhorne, Pennsylvania 19047, at which time testimony and other comments from the public will be heard. Pertinent Project information to be considered is as follows:

Project Owner: **Kampus Klothes, LLC**, a Pennsylvania limited liability company.

Operating Company: **Kampus Klothes, Inc.**, a Pennsylvania corporation.

Amount of Tax-exempt Obligations: Not to exceed \$6,500,000.

Location of Project: Lots 15 and 16, Warwick Business Campus, Warwick Township, Bucks County, Pennsylvania (Tax Parcel Nos. 05-013-010-016 and 05-013-010-017).

Project Description: The proceeds of the tax exempt obligations will be used for a project involving the following: (1) the acquisition of approximately 7.45 acres and the construction, planning, designing and equipping of an approximately 42,000 square foot manufacturing facility at the above-referenced location; (2) the purchase of equipment to be used in the Project facility; (3) the reimbursement or refinancing of costs and expenses incurred in connection with the Project; (4) the payment of the costs and expenses of the financing; and (5) financing other proper and lawful purposes (together, the “Project”). This Project will be used for the benefit of the Operating Company in its business of manufacturing imprinted sportswear and customized by silk screening, embroidery, patches, etc.

The public hearing is being held through the Authority as the issuer of the proposed tax-exempt obligations and on behalf of the Board of County Commissioners as the elected governmental officials who must approve plan of finance and the issuance of such tax-exempt obligations in accordance with requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended.

The tax exempt obligations will not pledge the general credit of the Authority, the County of Bucks or the Township of Warwick or the credit or taxing power of the Commonwealth of Pennsylvania or any political subdivision thereof.

This Notice is published in accordance with the public notice requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended, and the regulations thereunder.
