Project Description: The proceeds of the tax exempt obligations will be used for a project involving the following: (1) the acquisition of approximately 6.465 acres and comprising of approximately 43,000 square foot facilities and the planning, designing, equipping, constructing and furnishing of renovations and improvements to such facilities at the above-referenced location; (2) the reimbursement or refinancing of costs and expenses incurred in connection with the Project; and (3) the payment of the costs and expenses of the financing; and (4) financing other proper and lawful purposes (together, the "Project"). This Project will be used for the benefit of the Principal User in its business of manufacturing protective coatings and linings.
