NOTICE IS HEREBY GIVEN, as of October 2, 2025, of a Public Hearing to be held by the Bucks County Industrial Development Authority ("Authority") with respect to a project involving the issuance of tax-exempt obligations constituting a qualified small issue bond under Section 144 of the Internal Revenue Code of 1986, as amended, to finance or refinance the Project described below pursuant to a plan of finance. **Project Owner: 8 Headley Place, LLC,** a Pennsylvania limited liability company. (or another to be formed single purpose entity related to Griff & Associates, L.P.)

Principal User: Griff & Associates, L.P. d/b/a Griff Paper and Film.

**Amount of Tax–exempt Obligations:** Not to exceed \$9,000,000.

**Location of Project:** 8 Headley Place, Falls Township, Bucks County, Pennsylvania (Tax Parcel No. 13-032-084).

**Project Description:** The proceeds of the tax exempt obligations will be used for a project involving the financing and/or refinancing of the following: (1) the acquisition of approximately 4.5 acre site with an existing approximately 60,000+/- square foot facility; and the planning, designing, equipping, constructing and furnishing of renovations and improvements to such facilities at the above-referenced location; (2) the purchase and installation of equipment to be used in the facility; (3) the reimbursement or refinancing of costs and expenses incurred in connection with the Project; (4) the payment of the costs and expenses of the financing; and (5) financing other proper and lawful purposes (together, the "Project"). This Project will be used for the benefit of the Principal User in its business of manufacturing and distributing specialty paper and film products.

The public hearing is being held through the Authority as the issuer of the proposed tax-exempt obligations and on behalf of the Board of County Commissioners as the elected governmental officials who must approve plan of finance and the issuance of such tax-exempt obligations in accordance with requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended.

The tax exempt obligations will not pledge the general credit of the Authority, the County of Bucks or the Township of Falls or the credit or taxing power of the Commonwealth of Pennsylvania or any political subdivision thereof.
